3. HARVESTING DECISION-MAKING POLICY

• The Purpose of the policy is to ensure that forestry planning includes the multiple values identified through the EBM Plan, the Forest Stewardship Plan, and the Carbon and Timber Outcomes report. The outcomes of the policy are to create a decision-making framework with metrics that will assist the Board in making harvesting decisions and as a communications tool to assist the public in understanding harvesting decisions.

That Cheakamus Community Forest Board of Directors adopt the Harvesting Decision-Making Policy.

4. WORCA/CCF PLANNING POLICY

- The Purpose of the policy is to ensure that information is shared regularly between the CCF and WORCA in an effort to improve understanding and collaboration, and to reduce conflicts between forest harvesting and recreation trails and their users.
- Discussion:
 - i. General support for policy
 - ii. Consider what other groups it may be appropriate to develop similar policies with to avoid unintended consequences or alienation
 - iii. Develop an engagement policy with the Squamish Nation and Lil'wat Nation
- H. Edmonds will review language to ensure Indigenous cultural values are adequately included.

ACTION: ED to provide copy to H. Edmonds for review. Board will defer motion to adopt the policy until this step is completed.

ACTION: ED follow up with K. Edwards re: First Nations' engagement policy development

5. ASHLAUR TRADING CONTRACT

- Discussion on two topics:
 - i. Ashlaur Trading to act as logging broker
 - ii. Executive Director's authority to sign contracts
- Decision made to develop policy for identifying limits to ED authority, spending limits, and signing authority

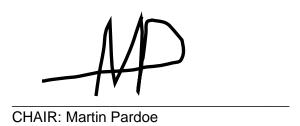
